

The following conditions are to be addressed within 30 days of the issue of the Crown Certificate for Building Works, and approved by a subsequent Crown Building Works Certificate:

- 1. The Clause 144 Referral of the Fire Engineering Report to FRNSW is to be completed.
- 2. For the Fire Engineering Report, provide an unconditional Peer Review Report.
