

## WEDDING OPEN DAY COMPETITION TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions of entry. Participation in this competition is deemed acceptance of these Terms and Conditions.
2. The Promoter is the Sydney Opera House Trust, Bennelong Point, Sydney NSW 2000. (ABN 69 712 101 035), (+612) 9250 7111.
3. Entry is open to Australian residents over the age of 18 who attend the Wedding Open Day on Friday 27 February 2026. Employees of the Promoter and their immediate families and agencies and companies associated with this competition are not eligible to enter.
4. The competition will take place for the duration of the 2026 Wedding Open Day at Sydney Opera House which commences at 5pm on Friday 27 February 2026 (AEDT) and finishes at 8pm on Friday 27 February 2026 (AEDT) (**Competition Period**).
5. You may only enter the competition once during the Competition Period. The Promoter reserves the right to disqualify any incomplete or automated entries. Multiple entries from the same individual are invalid.
6. To enter the competition, you must complete the form available at the Wedding Open Day, fill in your contact details and answer the question: ***Tell us in 25 words or less why you want to get married at the Sydney Opera House*** during the Competition Period.
7. This is a game of skill. All eligible entries will be judged by a panel of judges selected by the Promoter based on originality, creativity and relevance to the competition theme. The winners will be determined on Wednesday 11 March 2026.
8. The total prize pool value is \$8,800.00. There will be one major prize winner. The major prize consists of one free venue hire to the value of \$8,800.00 for either a wedding reception or a wedding ceremony and reception (and for no other purpose) in the Yallamundi Rooms at the Sydney Opera House (maximum capacity 150 guests). The venue hire must be booked by Tuesday 30 June 2026 and take place on a date before Friday 31 December 2027 between 5pm and 11pm (subject to availability). The prize is for venue hire only and does not include catering, theming or any other goods or services.
9. The Promoter's decision in relation to any aspects of the competition is final and binding on every person who enters and no correspondence will be entered into.
10. The prize winners will be notified by the Promoter via email. The prize must be redeemed by the winner by responding to that email by 5pm Friday 13 March 2026.

If for any reason, the winner does not claim the prize in the manner referred to in section 10 above, or if the contact details supplied by them are incorrect, the Promoter reserves the right to choose a second chance prize winner on Monday 16 March 2026, and that person will be the prize winner (and the same terms and conditions will apply).

If for any reason this promotion is cancelled or is not capable of running as planned, due to an intervention of any outside agent or event which naturally changes the result or prevents or hinders its determination, including but not limited to vandalism, power failures, tempests, natural disasters, civil unrest, strikes, pandemics; the Promoter may in its absolute discretion cancel the promotion and recommence it from the start on the same conditions subject to state regulation.
